At the March 1998 meeting, the Judicial Conference approved recommendation from its Committee on the Administration of the Bankruptcy System that each district court appoint a chief bankruptcy judge for a set term of up to seven years, with the possibility of reappointment.



At the March 1998 meeting, the Judicial Conference approved a recommendation from its Committee on the Administration of the Bankruptcy System that each District Court appoint a Chief Bankruptcy Judge for a set term of up to seven years, with the possibility of reappointment.

At a regularly scheduled meeting of the Judges of the Court, the Court considered the recommendation of the Judicial Conference and unanimously agreed that the term for the Chief Bankruptcy Judge in the Southern District of Florida should meet the same terms and conditions as apply to Chief District Judges.

This Administrative Order voids Administrative Order 98-40 issued July 22, 1998.
