

ADMINISTRATIVE ORDER 2003-111

**IN RE: MODIFICATION OF MAGISTRATE
JUDGE PAIRING ASSIGNMENT PLAN
(Northern Division)**



Administrative Order 2002-12 modified the Magistrate Judge pairing assignment plan for the Central (Fort Lauderdale) and Northern (West Palm Beach and Fort Pierce) Divisions. The modifications effectuated by that Order are for a period of three years, commencing April 11, 2002, and expiring March 31, 2005, subject to the following amendments. It is hereby

ORDERED that, commencing November 6, 2003, the Judges and Magistrate Judges for the Northern Division will be paired as follows:

It is also ORDERED that the Clerk of Court is directed to revise the case assignment system as follows:

In the event Magistrate Judge Hopkins enters an order of recusal in any criminal case, the case shall be reassigned to either Chief Magistrate Judge Vitunac (even-numbered) or to Magistrate Judge Johnson (odd-numbered). Orders of recusal entered by Magistrate Judge Lynch in Fort Pierce cases shall be reassigned to the paired Magistrate Judge. Any other recusals by Northern Division (West Palm Beach and Fort Pierce) Magistrate Judges shall be randomly reassigned from the appropriate wheel.

This Order vacates Administrative Orders 99-28 and 2000-68, and those portions of Administrative Order 2002-12 that are inconsistent with the changes herein stated.



It is also **ORDERED** that the Clerk of Court is directed to
revise the case assignment system as follows:

In the event Magistrate Judge Hopkins enters an order of
recusal in any criminal case, the case shall be reassigned to
either Chief Magistrate Judge Vitunac (even-numbered) or to
Magistrate Judge Johnson (odd-numbered). Orders of recusal entered
by Magistrate Judge Lynch in Fort Pierce cases shall be reassigned
to the paired Magistrate Judge. Any other recusals by Northern
Division (West Palm Beach and Fort Pierce) Magistrate Judges shall
be randomly reassigned from the appropriate wheel.

This Order vacates Administrative Orders 99-28 and 2000-68,
and those portions of Administrative Order 2002-12 that are
inconsistent with the changes herein stated.
