

ADMINISTRATIVE ORDER 2003-114

IN RE: MODIFICATION OF MAGISTRATE
JUDGE PAIRING ASSIGNMENT PLAN
(Central Division)



Administrative Order 2002-12 modified the Magistrate Judge pairing assignment plan for the Central (Fort Lauderdale) and Northern (West Palm Beach and Fort Pierce) Divisions. The modifications effectuated by that Order are for a period of three years, commencing April 11, 2002, and expiring March 31, 2005, subject to the following amendments. It is hereby

ORDERED that, commencing November 1, 2003, the Judges and Magistrate Judges for the Central Division will be paired as follows:

- Magistrate Judge Snow** - Chief Judge William J. Zloch
All criminal and civil cases
Judge James I. Cohn
All criminal and civil cases
Senior Judge Jose A. Gonzalez, Jr.
All civil cases
- Magistrate Judge Seltzer** - Judge Kenneth A. Marra
All criminal and civil cases
- Magistrate Judge Torres** - Judge William P. Dimitrouleas
All criminal and civil cases


In order to effect the orderly transfer of cases to Magistrate Judge Torres in accordance with the instant amendments, the following procedures shall apply:

As of the effective date of this order, Magistrate Judge Seltzer, formerly paired with Judge Dimitrouleas, shall retain

until disposition all previously-referred, fully-briefed motions in cases assigned to Judge Dimitrouleas. In addition, Judge Seltzer shall dispose of all other referred motions that become ripe for disposition in such cases until he has ruled on all fully briefed motions. Upon the Magistrate Judge Seltzer's disposition of all fully briefed motions in any case assigned to Judge Dimitrouleas, the Magistrate Judge shall certify to the assigned District Judge that he has ruled upon all such motions. Thereafter, District Judge Dimitrouleas will issue an order directing the Clerk of Court to transfer the case to Magistrate Judge Torres. Any consent trial, consent motion for summary judgment, and other "consent motion" shall remain with the magistrate judge who was assigned to the case when the consent was given. Those cases in which no motions are referred to Magistrate Judge Seltzer may be administratively transferred to Magistrate Judge Torres by the Clerk's Office.

This Order vacates those portions of Administrative Orders 2002-12 and 2003-86 that are inconsistent with the changes herein stated.
