

ADMINISTRATIVE ORDER 2021-17

IN RE: ESTABLISHMENT OF FAIRNESS AND DIVERSITY COMMITTEE FOR THE SOUTHERN DISTRICT OF FLORIDA



By this Administrative Order, the Court establishes a Fairness and Diversity Committee to be a resource for the Court in addressing issues relating to race, color, sex, gender, gender identity, pregnancy, sexual orientation, religion, national origin, age or disability or any other issues impacting fairness and diversity in the District.

IT IS ORDERED that the following persons are appointed as members of the Southern District of Florida's Fairness and Diversity Committee:

- 1. The Committee will assist the Court in its ongoing commitment to achieve the promises of equal justice and opportunity for all.
- 2. The Committee will consider, among other subjects, diversity in court staffing as well as court monitors, special masters and receivers, the CJA Panel and lead and liaison counsel in MDL proceedings.

- 3. The Committee will study the constitution of jury panels in the District and any other questions related to the operation of the Court consistent with promoting fairness and diversity.
- 4. The Committee will review outreach efforts and protocols—in both educational and employment contexts—to assist the Court in making diverse audiences aware of the work of the Court as well as career opportunities within the Court.
- 5. The Clerk of Court, or her designee, shall provide staff support to the Committee.
