Plan for Assignment of Matters by Judges Hoeveler, Nesbitt and
Atkins, to Magistrate Sorrentino

On September 10, 1985, District Judges William M. Hoeveler and Lenore Carrero Nesbitt, Senior Judge C. Clyde Atkins, Chief Magistrate Peter R. Palermo, Magistrate Charlene H. Sorrentino, and Court Executive Dyana Castro met and agreed upon the work to be performed by Magistrate Sorrentino for Judges Hoeveler, Nesbitt, and Atkins.

It was recognized that every fifth week is totally consumed by the duty assignments performed pursuant to 28 U.S.C. §636(a). Moreover, one half or more of the week following a duty week is usually consumed with matters growing out of the duty week, including motions to reduce bonds set during that week, and the voluminous paperwork generated by the duty calendars.

It was determined that in addition to the duty assignments, the Magistrate will receive by reference from the District Judges all prisoner civil rights complaints, all social security disability cases, and all habeas corpus cases filed pursuant to 28 U.S.C. §2254 and §2255.

Moreover, the three Judges will refer to the Magistrate certain other civil matters which may reasonably be accomplished in the available time, such as scheduling conferences, status conferences, pre-trial conferences, and settlement conferences, in certain selected cases.
