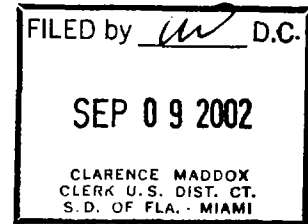

ORDER OF REINSTATEMENT

THIS CAUSE is before the Court on the Report and Recommendation of the Ad Hoc Committee on Attorney Admissions, Peer Review and Attorney Grievance (the "Committee") following a hearing conducted on July 29, 2002, pursuant to Rule IX.C of this Court's Rules Governing Attorney Discipline, on attorney Larry Wayne Sparks's Petition for Reinstatement as a Member of the Bar of this Court (the "Petition").

Having reviewed the Report and Recommendation, the Petition, and the attachments to the Petition, the Court agrees with the Committee that Petitioner is fit to resume the practice of law in this Court and should be reinstated immediately as a member in good standing of the Bar of this Court on certain conditions. Accordingly, the Report and Recommendation is therefore approved and attorney Larry Wayne Sparks ("Petitioner") is hereby reinstated as a member in good standing of the Bar of this Court on the following conditions:

1. Petitioner remains under contract with and continues to be monitored by Florida Lawyer's Assistance, Inc. through and including October 2, 2004.

2. Petitioner continues to attend periodic meetings of "Alcoholics Anonymous" or "AA" as required by Florida Lawyer's Assistance, Inc. through and including October 2, 2004.

3. Petitioner enters into a written agreement (the original of which shall be provided to the Clerk of the Court) with Florida Lawyer's Assistance, Inc. that it will monitor Petitioner's behavior, including his attendance at AA meetings, and furnish the Clerk of the Court with a written report if Petitioner should breach his contract with Florida Lawyer's Assistance, Inc.

4. Petitioner continues to remain under the professional treatment of his psychologist, William Ryan Ph.D.,¹ through and including October 2, 2004.

5. Petitioner enters into a written agreement (the original of which shall be provided to the Clerk of the Court) with his psychologist, William Ryan Ph.D.,² under which his psychologist agrees to furnish the Clerk of the Court with a written report of any violation by Petitioner of any recommended treatment.

6. Petitioner continues to remain under the medical supervision of his psychiatrist, Dr. Richard Seely,³

¹If for any reason Dr. Ryan is, or becomes, unable or unwilling to provide the required treatment, Petitioner shall promptly enter into the care of some other comparable psychologist (the "successor psychologist").



through and including October 2, 2004, and to take all medications prescribed by Dr. Seely.

7. Petitioner enters into a written agreement (the original of which shall be provided to the Clerk of the Court) with his psychiatrist, Dr. Richard Seely,⁴ under which his psychiatrist agrees to furnish the Clerk of the Court with a written report of any violation by Petitioner of any recommended treatment.

Petitioner's reinstatement shall be effective as of the date on which he furnishes the Clerk of the Court with all of the written agreements specified in paragraphs 3, 5 and 7 above.
