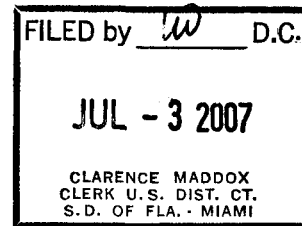

ADMINISTRATIVE ORDER 2007-32

IN RE:

**REASSIGNMENT OF EAST EVERGLADES
ACQUISITION PROJECT CASES FORMERLY
ASSIGNED TO JUDGE WILLIAM J. ZLOCH**



Administrative Order 2001-54 caused all pending Land Condemnation cases assigned to Senior Judge Lenore Nesbitt to be reassigned to then Chief Judge William J. Zloch. At the time reassignments occurred, approximately 1900 land condemnation cases were pending. Upon the conclusion of his term as Chief Judge, Judge Zloch sought to be relieved of the assignment of approximately 430 land condemnation cases that remain pending.

Accordingly, it is **ORDERED** that East Everglades Acquisition Project cases assigned to Judge William J. Zloch, which are listed in the Appendix to this Order, be reassigned to Chief Judge Federico A. Moreno effective this date.

It is further **ORDERED** that all new land condemnation cases filed after the effective date of this Order be directly assigned to Chief Judge Moreno or his designee. Magistrate Judge Robert Dubé shall remain the assigned Magistrate Judge for all purposes on all cases herein transferred.
