## **ADMINISTRATIVE ORDER 2010-11**

## In re: ORDER OF SUSPENSION OF ATTORNEY GARY MARK MILLS FLORIDA BAR #59625

## **ORDER OF SUSPENSION**

The above named attorney plead guilty to one count of conspiracy to commit bank fraud in a criminal case in this Court, and upon acceptance of that plea, he was found guilty. The Supreme Court of Florida then disbarred him from practicing law in Florida, effective April 14, 2009, following a February 26, 2009, order. Thereafter, the Clerk of this Court attempted to serve him at his court record address with an Order to Show Cause why this Court should not impose the same discipline, accompanied by the Supreme Court of Florida's Order of Disbarment. As of the date of this Order, the Clerk has been unable to obtain service, although it appears the attorney's agent signed for receipt. Rule IVA of the Southern District of Florida Attorney Discipline Rules provides in pertinent part: "Upon the filing with this court of a certified copy of a judgment of conviction demonstrating that any attorney admitted to practice...has been convicted...of any serious crime...the Court shall enter an order immediately suspending that attorney.... That suspension so ordered shall remain in effect until final disposition of the disciplinary proceedings to be commenced upon such conviction." Pursuant to the Rules Governing Attorney Discipline, United States District Court, Southern District of Florida,

IT IS ORDERED that said attorney be suspended from practice in this Court, effective immediately.

IT IS FURTHER ORDERED that this suspension shall remain in effect until final disposition of the disciplinary proceedings commenced upon the attorney's conviction, pursuant to Rule IVA, or until such time as the Court lifts this suspension upon the appearance and request of the attorney. The Clerk of Court shall also immediately revoke the attorney's CM/ECF password.

IT IS FURTHER ORDERED by this Court that the Clerk of Court shall attempt to serve a copy of this Order of Suspension upon the attorney at any known addresses.
