Administrative Order 2007-68 set forth this Court's Magistrate Judge Pairing Assignment Plan in Miami. In view of the Court's expected appointment of Jonathan Goodman on July 23, 2010, the Court modifies the assignments set out in Administrative Order 2007-68 and subsequent orders amending it. Accordingly, it is

ORDERED that effective upon his appointment the following categories of cases and duties will be assigned to Magistrate Judge Jonathan Goodman:

- (1) All recusals from other Magistrate Judges in both the Northern and Southern Divisions on which Akerman Senterfitt is not counsel of record;
- (2) The normal weekly duty rotation in Miami after August 16, 2010 as determined by Chief Magistrate Judge Stephen Brown;
- (3) Thirty (30) old *pro se* division cases selected by Magistrate Judge White no later than August 2, 2010 in the following categories:
 - (a) Ten (10) cases under 28 U.S.C. §§ 2241 and 2254;
 - (b) Ten (10) cases under 42 U.S.C. § 1983; and
 - (c) Ten (10) cases under 28 U.S.C. § 2255 from the Northern and Southern Divisions.
- (4) One criminal referral from each individual Magistrate Judge in both the Northern and Southern Divisions. The referral shall be made no later than August 30, 2010. Failure to do so is an election by the Magistrate Judge not to reassign any cases; and

(5) Two civil referrals from each individual Magistrate Judge in both the Northern and Southern Divisions. The referrals shall be made no later than August 30, 2010. Failure to do so is an election by the Magistrate Judge not to reassign any cases.

Therefore, Magistrate Judge Jonathan Goodman will be assigned at most thirty civil referrals, fifteen criminal referrals, and thirty *pro se* cases, plus all recusals from other Magistrate Judges in the Northern and Southern Divisions on which Akerman Senterfitt is not counsel of record. Recalled Magistrate Judges Peter R. Palermo, Robert L. Dubé, and Barry Garber will not reassign any cases at this time.
