## **ORDER OF SUSPENSION**

The above named attorney pled guilty to two felony counts of DUI with serious bodily injury and two misdemeanor counts of DUI with property damage in a criminal case in the Circuit Court of the Eleventh Judicial Circuit in and for Miami-Dade County, Florida styled, *State of Florida v. Panunzio*, Case No. F-09-05449. The Supreme Court of Florida then suspended him from practicing law in Florida, following a March 22, 2010 order. *See The Florida Bar v. Panunzio*, 33 So. 3d 36 (Fla. 2010).

Rule 4(a) of the Rules Governing Attorney Discipline, Local Rules of the United States District Court for the Southern District of Florida, provides in pertinent part: "Upon the filing with this Court of a certified copy of a judgment of conviction demonstrating that any attorney admitted to practice . . . has been convicted . . . of any serious crime . . . the Court shall enter an order immediately suspending that attorney. . . . The suspension so ordered shall remain in effect until final disposition of the disciplinary proceedings to be commenced upon such conviction." Given this background, pursuant to Rule 4(a) and the Court's inherent power to regulate membership in its bar for the protection of the public interest,

IT IS ORDERED that said attorney be suspended from practice in this Court, effective immediately, upon further Order of the Court. The Clerk of Court shall strike this attorney from the roll of attorneys eligible to practice in the United States District Court for the Southern District of Florida, and shall also immediately revoke his CM/ECF password.

IT IS FURTHER ORDERED by this Court that said attorney advise the Clerk of the Court of all pending cases before this Court in which he is counsel or co-counsel of record.

IT IS FURTHER ORDERED by this Court that the Clerk of Court shall serve a copy of this Order of Suspension upon the attorney at his court record address.
