THIS MATTER is before the Court upon the request for certification of the Consumer Bankruptcy Clinic of Nova Southeastern University Shepard Broad School of Law (the "CBC"). Pursuant to Rule 6 of this Court's *Special Rules Governing the Admission and Practice of Attorneys*, this request was reviewed to determine its eligibility for certification.

ORDERED AND ADJUDGED that the program is hereby certified by the Court under Rule 6(c) of the *Special Rules Governing the Admission and Practice of Attorneys*. Pursuant to Rule 6(d) of these Rules, Julie E. Hough, Esq. is hereby certified as supervising attorney. It is further

ORDERED AND ADJUDGED that the future certification of students enrolled in the CBC and other supervising attorneys shall be conditioned upon the filing with this Court of the

certifications described in, and required by, Rule 6(e) of the *Special Rules Governing the Admission and Practice of Attorneys*, and approval of such certifications by the Court.
