ORDER ON PETITION FOR REINSTATEMENT

THIS CAUSE is before the Court on attorney Mark Howard Klein's Petition for Reinstatement as a member of the Bar of this Court. Mr. Klein was reciprocally disciplined by this Court based upon Orders of Suspension by the Supreme Court of Florida. See The Florida Bar v. Klein, 114 So.3d 181 (Fla. 2013). On November 20, 2013, the Supreme Court of Florida entered orders lifting the suspensions. See The Florida Bar v. Klein, Nos. SC12-2210, SC12-2211, SC12-2238, SC12-2239 (Fla. Nov. 20, 2013). Mr. Klein was reinstated as a member in good standing with The Florida Bar on November 27, 2013. Mr. Klein was subsequently suspended on July 2, 2015, for forty-five days by order of the Supreme Court of Florida. See The Florida Bar v. Klein, 173 So.3d 967 (Fla. 2015). On August 20, 2015, Mr. Klein was automatically reinstated and is currently a member in good standing with The Florida Bar.

Pursuant to Rule 9(c) of this Court's Rules Governing Attorney Discipline, upon being submitted to the Court for its consideration, having reviewed the Petition, and being otherwise fully advised, the Court, by majority vote of the Judges, GRANTS the Petition for Reinstatement and finds that Mr. Klein qualifies for readmission to this Court's Bar. The Court further orders that Petitioner be reinstated as a member in good standing to the Bar of this Court.
