## **ORDER OF SUSPENSION**

On December 26, 2018, the Supreme Court of Florida entered an Order of Suspension, suspending Sonia Yvette Amador from the practice of law. *See The Florida Bar v. Amador*, No. SC18-1678, 2018 WL 6819512 (Fla. Dec. 26, 2018) (ECF No. 1). The suspension was predicated on The Florida Bar's Petition for Contempt and Order to Show Cause and the attorney's failure to file a response to the Supreme Court of Florida's Order to Show Cause. The Clerk attempted to serve attorney Amador by certified mail with an Order to Show Cause why this Court should not impose the same discipline, accompanied by the Supreme Court of Florida's Order of Suspension. (ECF No. 2). Service at Amador's Florida Bar address was returned – "Return To Sender – Attempted – Not Known – Unable to Forward." Service at Amador's court record address was attempted but no return receipt was received. A second attempt was made to both addresses on February 8, 2019. A return receipt to the court record address was received and filled out with an illegible signature and without notation as to "agent" or "addressee."

Rule 8(a) of the Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, Local Rules of the United States District Court for the Southern District of Florida, requires that "[a]n attorney admitted to practice before this Court shall, upon being subjected to reprimand, suspension, or disbarment . . ., promptly inform the Clerk of the Court of such action." Rule 8(d) provides in pertinent part that after expiration of the time for submitting a response to an Order to Show Cause, "the Court may impose the identical discipline or may impose any other sanction the Court may deem appropriate." Even if service is contested, Local Rule 11.1(g) imposes upon the members of this

Bar an obligation to provide updated contact information to the Clerk within seven days of any change,

and that "the failure to comply shall not constitute grounds for relief from deadlines imposed by Rule or

by the Court." This obligation to maintain current contact information is reiterated in the Court's

CM/ECF Administrative Procedures Manual, section 3D, compliance with which is mandated by Local

Rule 5.1. Given this background, pursuant to Rule 8(a) and (d), Local Rule 11.1(g) and the Court's

inherent power to regulate membership in its bar for the protection of the public interest, see Chambers

v. NASCO, Inc., 501 U.S. 32, 43 (1991) ("[A] federal court has the power to control admission to its bar

and to discipline attorneys who appear before it."),

IT IS ORDERED that said attorney be suspended from practice in this Court, effective

immediately. The attorney may not resume the practice of law before this Court until reinstated by order

of this Court. See Rule 12(a). The Clerk of Court shall strike this attorney from the roll of attorneys

eligible to practice in the United States District Court for the Southern District of Florida and shall also

immediately revoke the attorney's CM/ECF password.

IT IS FURTHER ORDERED by this Court that said attorney advise the Clerk of Court of all

pending cases before this Court in which she is counsel or co-counsel of record.

IT IS FURTHER ORDERED by this Court that the Clerk of Court attempt to serve by certified

mail a copy of this Order of Suspension upon the attorney at her court record and Florida Bar addresses.
