### **ORDER ON PETITION FOR REINSTATEMENT**

THIS CAUSE is before the Court on attorney Omar Javier Arcia's Petition for Reinstatement as a member of the Bar of this Court. Pursuant to Rule 12(c) of this Court's Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, this Court referred the matter to the Ad Hoc Committee on Attorney Admissions, Peer Review, and Attorney Grievance ("Committee"). Arcia appeared before the Committee on August 28, 2018. The Committee issued its Report and Recommendation on January 31, 2019, recommending that "Arcia be readmitted on a probationary basis, subject to" certain conditions.

Pursuant to Rule 12(c) and (d), this matter was taken up at a regularly scheduled Judges' Meeting held on May 16, 2019. Upon consideration of the Committee's Report and Recommendation and review of Arcia's disciplinary file, by unanimous vote of all active judges and senior judges eligible to vote, it is hereby

ORDERED AND ADJUDGED that the Committee's Report and Recommendation is ADOPTED, and Arcia's Petition for Reinstatement is GRANTED IN PART. Arcia is reinstated as a member in good standing to the Bar of this Court on a probationary basis, subject to the following conditions:

(1) Arcia may appear as co-counsel of record, provided that another attorney also appears as co-counsel with Arcia, and appears on all filings, including initial filings, and provided that Arcia's co-counsel be experienced in federal practice and in the subject matter of the litigation itself; and (2) After six (6) months from the date of this Order, Arcia may apply to have the probationary conditions lifted by submitting a written request to the Court to appear before the Committee. Arcia should be prepared at that time to provide a complete accounting to the Committee of the appearances he has made since his readmission on a probationary basis, including a description of the relevant experience of his co-counsel in such matters, and their respective responsibilities in the matter.
