

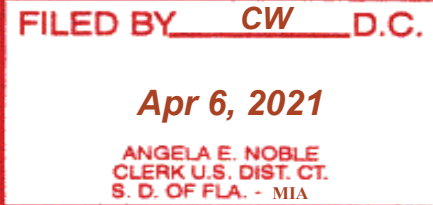

ADMINISTRATIVE ORDER 2021-32

IN RE:

EXEMPTION OF FEES TO ACCESS PACER  
FOR DR. CHEN HUANG

The United States District Court for the Southern District of Florida maintains case information online with the Public Access to Court Electronic Records (PACER) website. The Court desires to encourage the public's use of the database and to continue to promote public access and to avoid unreasonable burdens on both users and court staff in retrieving data.

The Court finds that Dr. Chen Huang, as an individual researcher associated with an educational institution, falls within the class of users listed in the fee schedule as being eligible for a fee exemption. Additionally, Dr. Huang has demonstrated that an exemption is necessary in order to avoid unreasonable burdens and to promote public access to information. It is hereby

**ORDERED AND ADJUDGED** that Dr. Chen Huang shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court, to the extent such use is incurred in the course of his research specifically whether the introduction of the Greenhouse Gas Reporting Program (GHGRP) in the U.S. improves publicly listed companies' social behaviors by reducing the probability of environmental related lawsuits. Dr. Huang will need environmental related litigation data from 2000 to 2020. Dr. Huang shall not be exempt from the payment of fees

incurred in connection with other uses of the PACER system in this Court.

Additionally, the following limitations apply:

1. this fee exemption applies only to Dr. Chen Huang and is valid only for the purposes stated above;
2. this fee exemption applies only to the electronic case files of this Court that are available through the PACER system;
3. by accepting this exemption, Dr. Huang agrees not to sell for profit any data obtained as a result of receiving this exemption;
4. Dr. Huang is prohibited from transferring any data obtained as a result of receiving this exemption, including redistribution via internet-based databases;
5. this exemption is valid March 1, 2021, to September 30, 2021.

This exemption may be revoked at the discretion of the Court at any time. The Clerk of Court for the United States District Court for the Southern District of Florida shall provide the PACER Service Center with any detailed information the Center may require to implement this Order.
