EXEMPTION OF FEES TO ACCESS PACER FOR THIEN DONG

The United States District Court for the Southern District of Florida maintains case information online with the Public Access to Court Electronic Records (PACER) website. The Court desires to encourage the public's use of the database, continue to promote public access, and avoid unreasonable burdens on both users and court staff in retrieving data.

The Court finds that Thien Dong, as an individual researcher associated with an educational institution, falls within the class of users listed in the fee schedule as being eligible for a fee exemption. Additionally, Ms. Dong has demonstrated that an exemption is necessary to avoid unreasonable burdens and to promote public access to information. Therefore, it is

**ORDERED AND ADJUDGED** that Thien Dong is exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court, to the extent such use is incurred in the course of her research on the effect of corporate lawsuits (between start-ups and incorporated firms) on the direction and intensity of defendants' future corporate venturing investment activities. She requires access to 33,553 cases (list attached) in which both parties are companies, and specifically identified cases in which one of 435 big U.S. companies was listed as defendant. She intends to manually access the parties and facts' sections of the dockets to complete her research project. Ms. Dong is not exempt from the payment of fees incurred in connection with other uses of the PACER system in this Court. Additionally, the following limitations apply:

## IN RE:

1. this fee exemption applies only to Thien Dong and is valid only for the purposes stated above;

2. this fee exemption applies only to the electronic case files of this Court that are available through the PACER system;

3. by accepting this exemption, Ms. Dong agrees not to sell for profit any data obtained as a result of receiving this exemption;

4. Ms. Dong is prohibited from transferring any data obtained as a result of receiving this exemption, including redistribution via internet-based databases;

5. this exemption is valid November 30, 2022, through May 31, 2023.

This exemption may be revoked at the discretion of the Court at any time. The Clerk of

Court for the United States District Court for the Southern District of Florida shall provide the

PACER Service Center with any detailed information the Center may require to implement this

Order.
