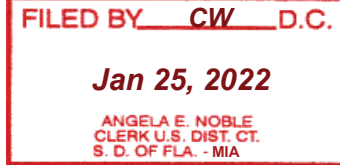

**IN RE: APPOINTMENT OF FEDERAL
MAGISTRATE JUDGE MERIT SELECTION PANEL
REGARDING MAGISTRATE JUDGE VACANCIES
IN FORT LAUDERDALE AND MIAMI, FLORIDA**



Pursuant to the provisions of the Federal Magistrates Act, 28 U.S.C. section 631(b)(5); the regulations of the Judicial Conference of the United States Establishing Standards and Procedures for the Appointment of United States Magistrate Judges; and by action of the Judges of this Court, the residents of this District listed below are hereby appointed as members of the Federal Magistrate Judge Merit Selection Panel for the upcoming vacancies due to the retirement of Magistrate Judge Lurana S. Snow on May 31, 2022, and the retirement of Magistrate Judge Chris M. McAliley on January 20, 2023.

The duty of this Panel is to consider and recommend to the United States District Court for the Southern District of Florida persons qualified to fill one (1) full-time United States Magistrate Judge position with a duty station in Fort Lauderdale, Florida, and one (1) full-time United States Magistrate Judge position with a duty station in Miami, Florida.



The Panel will meet in person as necessary, interview applicants, and will make its recommendation of eight (8) applicants to the Court by May 2, 2022.
