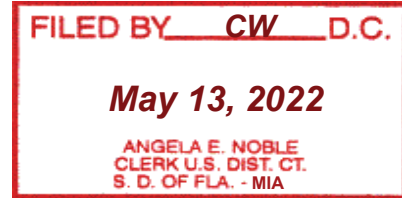

IN RE: RE-ESTABLISHMENT OF COMMITTEE
REGARDING FORT LAUDERDALE FEDERAL
COURTHOUSE



On July 30, 2021, the Court dissolved the Committee Regarding Fort Lauderdale Federal Courthouse given Congressional funding and steps toward site acquisition and design for a new federal courthouse in Fort Lauderdale. It has now come to the Court's attention that the Congressional funding previously allocated may be inadequate for the construction of a new federal courthouse in Fort Lauderdale. Accordingly, the Court is re-establishing the Committee Regarding Fort Lauderdale Federal Courthouse. It is hereby
