## ORDER ON PETITION FOR REINSTATEMENT

THIS CAUSE is before the Court on attorney Raul Enrique Garcia, Jr.'s Verified Petition for Reinstatement as a member of the Bar of this Court. [ECF No. 5]. Mr. Garcia was reciprocally disciplined based on an Order of Suspension by the Supreme Court of Florida. *See The Florida Bar v. Raul Enrique Garcia, Jr.*, No. SC17-1234, 2019 WL 1769143 (Fla. April 23, 2019) [ECF No. 1] and Administrative Order 2019-41 [ECF No. 4]. On October 29, 2021, Mr. Garcia filed a Verified Petition for Reinstatement with the Florida Supreme Court. After consideration of an uncontested report of the referee, the Supreme Court of Florida issued an Order of Reinstatement on May 26, 2022, reinstating Mr. Garcia as a member in good standing of The Florida Bar. *See The Florida Bar Re: Garcia*, No. SC21-1501, 2022 WL 1670521 (Fla. May 26, 2022) [ECF No. 5, Ex. d].

Pursuant to Rule 12(c) of the Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, Local Rules of the United States District Court for the Southern District of Florida, upon consideration of the Petition, exhibits to the Petition, and being otherwise fully advised, the Court finds that Mr. Garcia qualifies for reinstatement to this Court's Bar. Accordingly, the Court **GRANTS** Mr. Garcia's Petition for Reinstatement and orders that he be

reinstated as a member in good standing to the bar of this Court.
