

ADMINISTRATIVE ORDER 2023-23

IN RE: APPOINTMENT OF FEDERAL MAGISTRATE JUDGE MERIT SELECTION PANEL REGARDING THE UPCOMING MAGISTRATE JUDGE VACANCY IN MIAMI, FLORIDA

The Panel will meet in person as necessary, interview applicants, and will make its recommendation of five (5) applicants to the Court by July 2, 2023.

All Panel members have been advised in writing of the restriction set forth in § 420.30.20(d) of the Regulations of the Judicial Conference of the United States Establishing Standards and Procedures for the Appointment and Reappointment of United States Magistrate Judges.

This Federal Magistrate Judge Merit Selection Panel and the term of each member shall expire on November 3, 2023, unless otherwise extended or modified by order of this Court.
