ORDERED that the Ad Hoc Committee is charged with assisting the United States District Court, Southern District of Florida, in the review of applications of admission and the continuing eligibility for certification of programs, supervising attorneys, and students as well as implementation and evaluation of these Rules. It is also the purpose of the Ad Hoc Committee, through peer review, to determine whether individual lawyers are failing to perform to an adequate level of competency necessary to protect the interests of their clients, and to establish and administer a remedial program designed to raise the competence of a lawyer who is not performing adequately. Further, the Ad Hoc Committee shall investigate allegations of lawyer misconduct referred by the Court and submit written findings and recommendations as to any appropriate discipline the Court should impose.

The Court and the Committee acknowledge the contributions of, and express appreciation to attorney Ryan Zagare for his many years of dedication and service to the Ad Hoc Committee on Attorney Admissions, Peer Review and Attorney Grievance.

This Committee shall remain in existence until further order of the Chief Judge. The members shall serve renewable terms of three (3) years, and their terms shall be staggered so that one-third of the members' terms expire each year.¹
