## **ADMINISTRATIVE ORDER 2023-60**

The United States District Court for the Southern District of Florida maintains case information online with the Public Access to Court Electronic Records (PACER) website. The Court desires to encourage the public's use of the database, continue to promote public access, and avoid unreasonable burdens on both users and court staff in retrieving data.

Herbrina D. Sanders, as an adjunct professor and individual researcher associated with an educational institution, falls within the class of users listed in the fee schedule as being eligible for a fee exemption. Additionally, Ms. Sanders has demonstrated that an exemption is necessary to avoid unreasonable burdens and to promote public access to information. Therefore, it is

ORDERED AND ADJUDGED that Herbrina D. Sanders is exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court, to the extent such use is incurred in her research into 15-20 cases related to human sex trafficking to be used as teaching material for a law school human sex trafficking class in the fall 2023. Ms. Sanders is not exempt from the payment of fees incurred in connection with other uses of the PACER system.

Additionally, the following limitations apply:

- 1. this fee exemption applies only to Herbrina D. Sanders and is valid only for the purposes stated above;
- 2. this fee exemption applies only to the electronic case files of this Court that are available through the PACER system;

- 3. by accepting this exemption, Herbrina D. Sanders agrees not to sell for profit any data obtained as a result of receiving this exemption;
- 4. Ms. Sanders is prohibited from transferring any data obtained as a result of receiving this exemption, including redistribution via internet-based databases; and
- 5. this exemption is valid retroactively from August 14, 2023, through November 30, 2023.

This exemption may be revoked at the discretion of the Court at any time. The Clerk of Court for the United States District Court for the Southern District of Florida shall provide the PACER Service Center with any detailed information the Center may require to implement this Order.
