THIS CAUSE came before the Court on Petitioner, Leonel R. Benitez's Verified Petition for Reinstatement to Membership in Good Standing [ECF No. 5], filed on December 12, 2025.

On July 20, 2023, the Supreme Court of Florida suspended Mr. Benitez from the practice of law. *See Fla. Bar v. Benitez*, No. SC2022-0649, 2023 WL 4636797, at *1 (Fla. July 20, 2023). On October 2, 2023, this Court imposed reciprocal discipline, suspending Mr. Benitez from the practice of law in the U.S. District Court for the Southern District of Florida. (*See* Order of Suspension [ECF No. 3] 2). On March 20, 2025, the Supreme Court of Florida reinstated Mr. Benitez as a member in good standing of The Florida Bar. *See Fla. Bar re Benitez*, No. SC2024-1381, 2025 WL 869425 (Fla. Mar. 20, 2025).

Upon review of the Petition, and under Rule 12(c) of the Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, Local Rules of the U.S. District Court for the Southern District of Florida, the Court finds that Mr. Benitez qualifies for reinstatement to the Bar of the U.S. District Court for the Southern District of Florida.
