ORDER OF SUSPENSION

On January 16, 2025, the Supreme Court of Florida suspended Thomas Grant Neusom from the practice of law. *See Fla. Bar v. Neusom*, No. 2024-0611, 2025 WL 211543, at *1 (Fla. Jan. 16, 2025). Subsequently, on February 25, 2025, the Clerk of this Court attempted to serve Mr. Neusom with an Order to Show Cause [ECF No. 2] — providing him 30 days to explain why reciprocal discipline should not be imposed — along with a copy of the Florida Supreme Court's suspension order. The Clerk sent the materials to both of Mr. Neusom's last known addresses. Each time, the mail came back stamped: "Return to Sender — No Such Number — Unable to Forward." On April 3, 2025, the Clerk made second attempts to both addresses with the same result.

Under Rule 8(a) of the Southern District of Florida Local Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys ("Attorney Rules"), attorneys admitted to practice before this Court must promptly notify the Clerk if they are disciplined by another court. *See id.* Attorney Rule 8(d) authorizes the Court, once the time to respond to an order to show cause has lapsed, to impose reciprocal discipline or any other sanction it deems appropriate. *See id.*

Rule 11.1(g) of the Local Rules for the Southern District of Florida ("Local Rule") further obligates members of this Bar to update their contact information within seven days of any change, warning that "failure to comply shall not constitute grounds for relief from deadlines imposed by Rule or by the Court." *Id.* This obligation is echoed in Section 3D of the Court's CM/ECF Administrative Procedures Manual, compliance with which is mandatory under Local Rule 5.1.

In light of the above, and pursuant to Attorney Rules 8(a) and (d), Local Rule 11.1(g), and the Court's inherent authority to oversee membership in its bar and safeguard the public interest, *see Chambers v. NASCO, Inc.*, 501 U.S. 32, 43 (1991) (citation omitted), it is

ORDERED as follows:

1. Mr. Neusom is suspended from the practice of law in the U.S. District Court for the Southern District of Florida, effective immediately. He may not resume practice before this

Court unless and until reinstated by court order. See Att'y Rule 12(a).

2. Within **fourteen (14) days** of receipt of this Order, Mr. Neusom shall notify the Clerk

of Court of any active cases in which he appears as counsel or co-counsel of record in this District.

3. The Clerk is directed to **STRIKE** Mr. Neusom from the roll of attorneys authorized to

practice before this Court and to immediately revoke his CM/ECF credentials.

4. The Clerk shall promptly attempt service of this Order via certified mail to Mr.

Neusom's court record address and any addresses on file with The Florida Bar.
