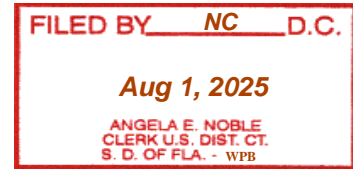

**ADMINISTRATIVE ORDER 2025-56**

**IN RE: MEMBERSHIP OF STANDING COMMITTEES**
