## **ORDER OF SUSPENSION**

On October 20, 2025, the Supreme Court of Florida entered an Order of Suspension [ECF No. 1], suspending Kathryn Wilburn Drey from the practice of law. *See The Florida Bar v. Drey*, No. SC2025-1644, 2025 WL 2952558 (Fla. Oct. 20, 2025). The suspension followed a Notice of Judgment of Guilt [ECF No. 2], that disclosed Ms. Drey was adjudicated guilty on March 28, 2023, of one count of Acts Affecting a Personal Financial Interest, a Class D felony. *See U.S. v. Drey*, No. 3:23-cr-0017-MCR, Judgment, filed July 26, 2023 (N.D. Fla. 2023).

Under Rule 7(a) of the Southern District of Florida Local Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys ("Attorney Rule(s)"), "[u]pon the filing with this Court of a certified copy of a judgment of conviction demonstrating that any attorney admitted to practice before the Court has been convicted in any court of the United States . . . of any serious crime . . . the Court shall enter an order immediately suspending that attorney[.]" *Id.* (alterations added). Under Attorney Rule 7(b), a "serious crime" "include[s] any felony[.]" *Id.* (alterations added).

Given this background, under Attorney Rules 7(a) and (b) and the Court's inherent power to regulate membership in its bar for the protection of the public interest, *see Chambers v. NASCO, Inc.*, 501 U.S. 32, 43 (1991) ("[A] federal court has the power to control admission to its bar and to discipline attorneys who appear before it." (alteration added; citation omitted)), it is

## **ORDERED AND ADJUDGED** as follows:

1. Ms. Drey is suspended from practice in this Court, effective immediately. Ms. Drey

may not resume the practice of law before this Court until reinstated by court order. See Att'y Rule 12(a).

- 2. The Clerk of Court shall **STRIKE** Ms. Drey from the roll of attorneys eligible to practice in the United States District Court for the Southern District of Florida and shall also immediately revoke the attorney's CM/ECF password.
- 3. The Clerk of Court shall attempt to serve a copy of this Order of Suspension on Ms. Drey by certified mail at her court record and Florida Bar addresses.
