

ORDER

THIS CAUSE came before the Court on Petitioner, Paul K. Silverberg's Verified Petition for Reinstatement [ECF No. 6], filed on March 5, 2026.

On September 30, 2020, the Supreme Court of Florida suspended Mr. Silverberg from the practice of law. *See Fla. Bar v. Silverberg*, No. SC18-1216, 2020 WL 5823795, at *1 (Fla. Sep. 30, 2020). On November 5, 2020, this Court imposed reciprocal discipline, suspending Mr. Silverberg from the practice of law in the U.S. District Court for the Southern District of Florida. (*See* Nov. 5, 2020 Order of Suspension [ECF No. 4] 2).¹ On November 7, 2024, the Supreme Court of Florida reinstated Mr. Silverberg as a member in good standing of The Florida Bar. *See Fla. Bar re Silverberg*, No. SC2024-1014, 2024 WL 4706620, at *1 (Fla. Nov. 7, 2024).

Upon review of the Petition, and under Rule 12(c) of the Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, Local Rules of the U.S. District Court for the Southern District of Florida, the Court finds that Mr. Silverberg qualifies for reinstatement to the Bar of the U.S. District Court for the Southern District of Florida.


Accordingly, it is
