ORDER

**THIS CAUSE** came before the Court on Petitioner, Randall Lawrence Gilbert's Petition for Reinstatement [ECF No. 4], filed on March 31, 2026.

On November 3, 2017, the Supreme Court of Florida suspended Mr. Gilbert from the practice of law. *See Fla. Bar v. Gilbert*, No. SC15-2004, 2017 WL 5054403, at \*1 (Fla. Nov. 3, 2017). On December 29, 2017, this Court imposed reciprocal discipline, suspending Mr. Gilbert from the practice of law in the U.S. District Court for the Southern District of Florida. (*See Dec. 29, 2017 Order of Suspension [ECF No. 2] 2*).<sup>1</sup> On September 4, 2025, the Supreme Court of Florida reinstated Mr. Gilbert as a member in good standing of The Florida Bar. *See Fla. Bar re Gilbert*, No. SC2025-0580, 2025 WL 2555856, at \*1 (Fla. Sept. 4, 2025).

Upon review of the Petition, and under Rule 12(c) of the Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, Local Rules of the U.S. District Court for the Southern District of Florida, the Court finds that Mr. Gilbert qualifies for reinstatement to the Bar of the U.S. District Court for the Southern District of Florida.

Accordingly, it is


**ORDERED AND ADJUDGED** that Petitioner, Randall Lawrence Gilbert's Petition for Reinstatement [ECF No. 4] is **GRANTED**. Mr. Gilbert is reinstated as a member in good standing
