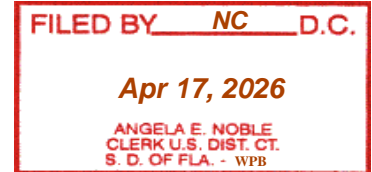



The Panel will meet in person as necessary, and after consideration of comments and feedback obtained, will make its recommendation to the Court by July 16, 2026.

All Panel members have been advised in writing of the restriction set forth in section 420.30.20(d) of the Regulations of the Judicial Conference of the United States Establishing Standards and Procedures for the Appointment and Reappointment of United States Magistrate Judges.

This Federal Magistrate Judge Merit Selection Panel and the term of each member shall expire on August 28, 2026, unless otherwise extended or modified by order of this Court.
