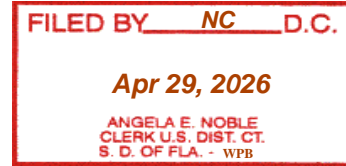

ADMINISTRATIVE ORDER 2026-30

**IN RE: AMENDED MAGISTRATE JUDGE
PAIRING ASSIGNMENT PLAN FOR
MIAMI, FORT LAUDERDALE, WEST PALM
BEACH, FORT PIERCE, AND KEY WEST**



The Magistrate Judge Pairing Assignment Plan in the Southern District of Florida is set forth in Administrative Orders 2020-45, 2020-45A, 2020-45B, 2020-91, 2021-53, 2022-6, 2022-6A, 2022-47, 2022-67, 2022-79, 2023-9, 2023-81, 2024-23, 2024-23A, 2024-69, 2024-86, 2025-52, 2025-52A, 2025-64, 2026-4, and 2026-23. From time to time pairings are adjusted to account for workloads. The Court amends Administrative Order 2026-23 to pair Chief Judge Altonaga, Judge Bloom, and Judge Becerra with Magistrate Judge Augustin-Birch for Fort Lauderdale assignments. Accordingly, it is

ORDERED that effective April 29, 2026, Magistrate Judge Pairings shall be as follows:

It is further **ORDERED** as follows:

All previously referred matters shall be handled by the Magistrate Judge to whom the matter was referred unless otherwise ordered by the District Judge.

All recusals by Magistrate Judges in Miami shall continue to be handled by random and blind assignment to another Magistrate Judge from Miami. If all Miami Magistrate Judges recuse, then random and blind assignment shall be to a Fort Lauderdale Magistrate Judge. If all Miami and Fort Lauderdale Magistrate Judges recuse, then random and blind assignment shall be to a West Palm Beach Magistrate Judge.

This amended Magistrate Judge Pairing Assignment Plan shall remain in effect until further order.
