Prisoners raising civil rights claims, like other civil litigants, have no absolute constitutional right to counsel. See <i>Poole v. Lambert</i> , 819 F.2d 1025, 1028 (11th Cir. 1987) (explaining this principle in a prisoner's section 1983 action). Appointment of counsel in civil cases is, rather, a privilege "justified only by exceptional circumstances," such as the presence of "facts and legal issues [which] are so novel or complex as to require the assistance of a trained practitioner." <i>Id.</i> Where the facts and issues are simple or straight-forward, he or she usually will not need such help. <i>Kilgo v. Ricks</i> , 983 F.2d 189(11th Cir. 1993)Should circumstances change, the Court may decide to appoint counsel at a later date. However, at this early juncture, it is not clear that Plaintiffs case consists of novel facts or complex legal issues; hence, it is not necessary to appoint counsel.
