While the Motion is under advisement, the parties shall file a status report with the Court, on or before <b>June 28, 2024</b> , indicating whether they intend to avail themselves of the opportunity to consent to the Magistrate Judge. Then, if necessary, the Court will issue a full ruling on the Motion.
