BENCH WARRANT

I, **Angela E. Noble,** do hereby certify that pursuant to Florida Statute (CCP 209(b).) Any individual who fails to respond to a jury summons and is not excused may be fined \$250 for the first violation, \$750 for the second violation, and \$1500 for subsequent violations. (CCP 209(b).) Most importantly, any prospective trial juror who has been summoned for service, and fails to attend or to respond to the court and be excused from attendance, may be attached (have a bench warrant issued) and be compelled to attend. Following an order to show cause hearing, the court may find the prospective juror in contempt of court, punishable by \$1000 fine, 5 days in jail, or both. Bench warrant issued by Chief United State Judge Honorable **Cecilia M. Altonaga.** To any authorized law enforcement officer. An application by the federal law enforcement officer or an attorney for the government requests to arrest the citizen.

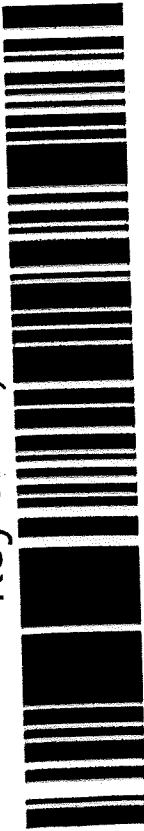
