- U.S. District Judge, Middle District of Florida (two vacancies)
- U.S. District Judge, Northern District of Florida (one vacancy)

The original, signed application must be provided to the Statewide Chair by the application deadline date and all Commission members are to be served electronically at their email addresses. There is a strict 40-page limit for the application and all enclosures. The application must be submitted in pdf format.

Applicants for U.S. District Judge, Middle District of Florida, who are selected by the Commission for personal interviews will be interviewed on Thursday, September 10, 2015 at the Ceremonial Courtroom 3A, George C. Young U.S. Courthouse, 401 West Central Boulevard, Orlando, Florida.

Applicants for U.S. District Judge, Northern District of Florida, who are selected by the Commission for personal interviews will be interviewed on Tuesday, September 15, 2015 at the U.S. Courthouse Annex, 3rd Floor Jury Assembly Room, 111 North Adams Street, Tallahassee, Florida.

The names of the applicants who are selected for personal interviews with the Commission, as well as the interview times, will be published on each website by August 14, 2015.
