Augustus v. Bd. of Pub. Instruction, 306 F.2d 862, 868 (5th Cir. 1962). "The proper remedy when a party mistakenly labels a denial as an affirmative defense is not to strike the claim but instead to treat it as a specific denial." Ramnarine v. CP RE Holdco 2009-1, LLC, No. 12-61716-CIV, 2013 WL 1788503, at *4 (S.D. Fla. Apr. 26, 2013). Defendants will not be permitted to raise any affirmative defenses at trial or at summary judgment that are, in fact, mislabeled denials. Notably, Defendants appear to be ready to concede that certain affirmative defenses are better construed as denials, and it also appears that Plaintiff's "good faith" conferral on this issue was less than thorough. At a minimum, Defendants' affirmative defenses serve to put Plaintiff on notice of the defenses that Defendants intend to raise against Plaintiff's claims. See Ramnarine at *4.
