**ORDER OF DISBARMENT**

The Supreme Court of Florida has entered an Order of Disbarment dated June 5, 2014, disbarring Ana I. Gardiner from the practice of law. *See The Florida Bar v. Gardiner*, No. SC11-2311, 2014 WL 2516419 (Fla. June 5, 2014). That disbarment was predicated on a report of referee. The Clerk served attorney Gardiner by certified mail with an Order to Show Cause why this Court should not impose the same discipline, accompanied by the Supreme Court of Florida's Order of Disbarment. Service at Gardiner's court record address was signed for by Ana I. Gardiner.

Rule 5(d) provides in pertinent part that after expiration of the time for submitting a response to an Order to Show Cause, "the Court may impose the identical discipline or may impose any other sanction the Court may deem appropriate." Given this background, pursuant to Rule (d) and the Court's inherent power to regulate membership in its bar for the protection of the public interest, *see Chambers v. NASCO, Inc.*, 501 U.S. 32, 43 (1991) ("[A] federal court has the power to control admission to its bar and to discipline attorneys who appear before it."),

IT IS ORDERED that said attorney be disbarred from practice in this Court, effective immediately. The Clerk of Court shall strike this attorney from the roll of attorneys eligible to practice in the United States District Court for the Southern District of Florida, and shall also immediately revoke the attorney's CM/ECF password.

IT IS FURTHER ORDERED by this Court that said attorney advise the Clerk of Court of

all pending cases before this Court in which she is counsel or co-counsel of record.

IT IS FURTHER ORDERED by this Court that the Clerk of Court attempt to serve by certified mail a copy of this Order of Disbarment upon the attorney at her court record address.
